Government's Net Revenue Collection: The First 8 Months of Fiscal Year 2024

(October 2023 - May 2024)

Mr. Pornchai Thiraveja, Director General of the Fiscal Policy Office and Spokesperson of the Ministry of Finance, stated that the government's net revenue collection in the first 8 months of fiscal year 2024 (October 2023 – May 2024) was 1,676,921 million Baht, which was 26,238 million Baht or 1.5% lower than the revenue target. The revenue from the Excise Department was lower than the target as a result of the temporary tax cut on diesel and benzene fuel as well as a slowdown in automobile and tobacco consumption. Meanwhile, when compared to the same period of the previous fiscal year, revenue collection was 1.5% higher than the previous fiscal year. After excluding special revenue of 53,130 million Baht from the base, revenue collection was 4.8% higher than the same period of the previous fiscal year.
