



## Government's Net Revenue Collection: The First 9 Months of Fiscal Year 2024 (October 2023 – June 2024)

Mr. Pornchai Thiraveja, Director General of the Fiscal Policy Office and Spokesperson of the Ministry of Finance, stated that the Ministry of Finance is confident that the revenue collection this year can achieve the revenue target in order to maintain strong fiscal position, as well as government's ability to finance necessary expenditures to support the economy.

The government's net revenue collection in the first 9 months of fiscal year 2024 (October 2023– June 2024 ) was 2,010,163 million Baht. The collected revenue from the Revenue Department, the Customs Department, State-Owned Enterprises (SOEs), and Other Government Agencies were higher than the target. However, the collected revenue from the Excise Department was affected by the temporary tax cut on diesel and benzene fuel to reduce the burden of energy costs on citizens and entrepreneurs. Furthermore, the measure to promote the usage of Electric Vehicles (EV) to support Thailand's transition to a low-carbon society and to become a regional EV manufacturing hub has resulted in lower tax rates. Consequently, the government's net revenue collection in the first 9 months of fiscal year 2024 was 26,169 million Baht or 1.3% lower than the revenue target, slightly improved from the first 8 months of fiscal year 2024. Nevertheless, the revenue from the Excise Department and revenue collection was higher than the same period of the previous fiscal year 12.3% and 2.8%, respectively. After excluding special revenue of 55,579 million Baht from the base, revenue collection was 5.8% higher than the same period of the previous fiscal year.
